RELEASE FORM

This Release Form (hereinafter called the "Release"), is executed in date month year, by and between, Oxalis Company Limited, Phong Nha Village, Phong Nha Town, Bo Trach District, Quang Binh Province, Vietnam (hereinafter

.....(hereinafter referred to as the "**Customer**").

Whereas: Oxalis is in the travel and leisure business and, as part of the services it provides to its customers, it runs transport, accommodation, jungle trekking, camping and caving activities;

Whereas: The Customer wishes to partake in one or more of the services offered by Oxalis; and

Whereas: Oxalis is willing to enter into an arrangement with the Customer under the following specific condition:

1. The Customer accepts the authority of the Oxalis guide, management and staff and follows all cave & trekking rules without exception while participating in an Oxalis tour.
2. The Customer agrees that if they cannot complete any section of the tour due to lack of physical ability, they will be turned around at the discretion of Oxalis.
3. The Customer agrees Oxalis will not be responsible for any costs associated with booking alternative travel arrangements including hotels, flights, bus tickets or train tickets, if the tour is delayed and does not finish according to the dates/times as detailed on the tour itinerary, or the Customer is turned around due to lack of physical ability.
4. The Customer agrees to be fully responsible for the equipment (headlights, helmets, life jackets) provided to them by Oxalis, and for their replacement costs if their equipment is lost or misplaced.
5. The Customer understands that Oxalis operates adventure tours requiring a high level of physical ability in a very remote location without medical facilities.
6. The Customer understands, acknowledges and agrees that adventure tourism activities such as trekking, camping and caving, etc. carry inherent risk factors and that dangers exist which are not related to safety equipment provided by the company. The Customer agrees that Oxalis cannot be held in any way responsible for any property damage, bodily harm, injury or death the Customer may sustain, either directly or indirectly, resulting from or in connection with any tour services provided by Oxalis.
7. The Customer acknowledges Oxalis will not accept responsibility or liability for any Customer who contravenes any laws or regulations of Vietnam.
8. The Customer understands that Oxalis may deem it advisable to amend an itinerary, and it may do so by varying or completely rerouting any tour from the scheduled itinerary. In this case, the Customer will make no objection or claim for compensation from Oxalis.
9. The Customer is required to buy the suitable insurance package under Vietnam's Tourism Law when participating Oxalis tours. Oxalis will buy the Customer travel insurance with the maximum 10.000.000 VND compensation. Besides, Oxalis will buy the Public Liability Insurance with the maximum 1.000.000 USD compensation.
10. The Customer agrees to give permission for Oxalis Company to use his/her likeness in photographs, video footage or electronic images in all forms, for media, advertising, and all other lawful purposes without compensation.
11. The Customer hereby releases, cancels, forgives and forever discharges Oxalis, and each of its directors, officers, heirs, successors and assigns in all capacities whatsoever, from all actions, claims, demands, damages, obligations, liabilities, controversies and executions, of any kind or nature whatsoever, whether known or unknown, whether suspected or not, which have arisen, or may have arisen, or shall arise, and the Customer does specifically waive any claim or right to assert any cause of action or alleged case of action or claim or demand which has, through oversight or error intentionally or unintentionally or through a mutual mistake, been omitted from this Release.
12. The Customer agrees to the provisions of this Release and its recitals must be read as a whole and are not severable and/or separately enforceable by either party hereto.

Oxalis and the customer agree to sign and implement this Release Form and it will take effect from the date of signing. The hard copy of this Release Form is kept at Oxalis Operation Office.
